## **PERMANENT INJUNCTION**

Pursuant to the Court's previous entry of Judgment (D.I. 265) in favor of Nox Medical, Ehf ("Nox Medical") and the stipulation of the parties, the Court hereby enters a permanent injunction as follows:

- 1. Defendant Natus Neurology, Inc. ("Natus") its officers, agents, servants, employees, attorneys and all persons in active concert or participation with any of the foregoing who have actual notice of the Permanent Injunction by service or otherwise are permanently enjoined as follows:
  - a. From making, using, selling or offering for sale the Natus XactTrace Single Use Pre-Sized RIP Belt that is the subject of C.A. No. 15-709-RGA (the "Accused Product") in the United States and from inducing the making, using, selling or offering for sale of the Accused Products in the United States; and
  - From importing the Accused Products into the United States or inducing others to do so.
- Nothing contained herein shall be construed to enjoin anyone from making, using, selling,
  offering for sale, or importing Natus's new XactTrace Single Use Pre-Sized RIP Belt as
  shown in Exhibit A hereto.

 The Permanent Injunction entered herein is effective immediately upon execution by the Court and entry on docket of the Court.
